Aims

- To introduce to students the ways in which Hong Kong's cultural and historical forms have been shaped by different kinds of narratives at various stages of her development as a community;
- 2. To equip students with the perspective and skills to analyze why and how people's imagination have been inscribed in texts ranging from the fictional, the historical, the biographical, the filmic, to other forms of public narratives; and
- 3. To raise students' awareness of identity construction as a process of articulating shared values and meanings shaped by mainstream narratives.

Learning Outcomes

- Students will be able to critically analyze the narratives of selected text(s) on the historical, political, economical, cultural and social development of Hong Kong, and to contextualize such analysis against the production of such text(s) and the values or ideological systems of the society;
- Students will be able to reflect upon how their experiences, knowledge, and 2. identification about Hong Kong and their own value systems have been shaped by mainstream narratives and dominant ideologies;
- Students will be able to compare and contrast different forms of narratives. 3. mainstream and non-mainstream, on selected current issues;
- 4. Students will be able to articulate their hopes, fears, anxieties, and desires on Hong Kong society and cultural identities by telling their own stories through creative means.

Teaching Methods

- Lectures and screenings on thematic topics;
- 2. Students' presentations and discussions in lectures (2-3 hours/wk) and tutorials (I hour/wk);
- 3. Students are expected to work on creative research group projects outside classroom using methods including but not limited to participatory observation, interviews, fieldwork research, and work as volunteers for different social groups and in different communities to gain more exposure and to reflect upon their own experiences and knowledge (more than 6 hours per week).

Measurement of Learning Outcomes

- The ability of students to critically analyze the narratives of selected text(s), and ١. their abilities to contextualize such analysis against the production of such text(s) and the values and/or ideological systems of the society will be measured by their performance in tutorial presentation and final examination, and the quality of verbal and written assignments;
- The ability of students to reflect upon how their experiences, knowledge, and 2. identification about Hong Kong and their own value systems have been shaped by mainstream narratives and the dominant ideologies will be measured by tutorial presentation, verbal and written assignments and final examination;
- The ability of students to compare and contrast different forms of narratives, mainstream and non-mainstream, on selected current issues will be measured by verbal and written assignments, and final examination;
- 4. The ability of students to articulate their hopes, fears, anxieties, and desires on Hong Kong society and cultural identities by telling their own stories through different creative research methods will be measured by the quality of their work assignment.

Assessment

Students will be graded on the basis of:

20% class participation;

30% class presentations;

20% research projects, volunteer work performance and reflection;

30% Take home examination.

形式: 同學在 23/10-4/12 期間,在選定的機構每周服務最少 5 個小時。具體工作及時間安排,則視乎個別機構。

名額:約10-15個。若申請的同學多於這個數目,則由課程導師負責挑選。

督導: 日常的督導工作由機構負責人負責。

評估方式:同學的總體表現,由機構負責人及課程導師共同進行評估。

Ⅲ 「論述香港」研究計劃:

目的: 讓同學從自己角度再現對香港社會的現狀、小寫歷史與文化身份,從而學習反思與建構自己的香港論述。

形式:每組 10 分鐘口頭報告及一份書面報告。

IV 考試:

目的: 評估同學的論述分析的能力及思考課堂內容的深度。
